ADDITIONAL INFORMATION	Contains lubricants

4. FIRST-AID MEASURES

ON SKIN CONTACT	In case of contact with molten material, immediately cool the skin with cold water. Hospital treatment is required to remove adhering material and for treatment of burns.
AFTER INHALATION	No effects known.
ON INGESTION	No effects known. Rinse mouth with water and drink more water. Contact a doctor in case of discomfort.
ON EYES CONTACT	Solid or dust may cause irritation or corneal injury due to mechanical action. Immediately flush eyes with plenty of water for at least 15 minutes and call a doctor, if irritation develops.



5. FIRE-FIGHT MEASURES

FIRE EXTINGUISHING MEDIA	Water spray, dry chemical extinguisher, foam, carbon dioxide. Unsuitable for safety reasons: water jet.
SPECIAL EXPOSURE HAZARDS	Can be emitted at temperatures of > 300 °C: Carbon monoxide, Hydrogen cyanide. Under special fire conditions, traces of other toxic substances are possible. Formation of further decomposition and oxidation products depends on the fire conditions.

6. ACCIDENTAL RELEASE MEASURES
